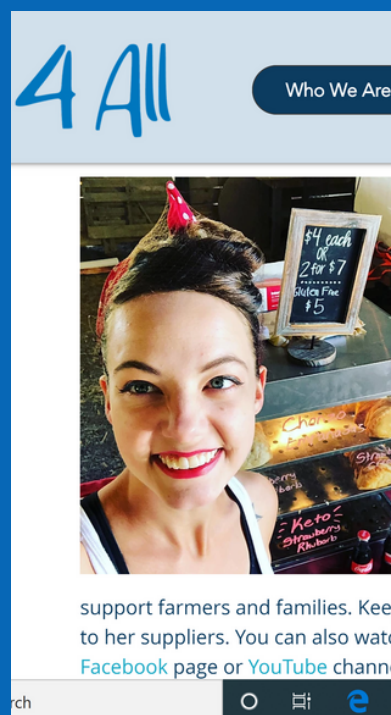

REFLECTIONS & ACCOMPLISHMENTS

CONNECTING

Networking was a goal for us this year which was accomplished primarily through professional development activities and introductions from our personal networks. Through these, we made contact with organizations and people who have become *support recipients*, like **Texas Parks & Wildlife Foundation**; *advisors*, like Joe Whipple from **Nonprofit Megaphone**; and *collaborators*, like **S.T.E.P.S. with Horses**, **PlayGrand Adventures**, and many in the **City of Grand Prairie**. We will continue nurturing these relationships while developing others. In 2020, *one focus area will be connecting more volunteers to opportunities* utilizing our volunteer pool, current connections, and future collaborators. These connections drive our own work forward and benefit our community of nonprofit collaborators and socially conscious citizens.

COMMUNICATING

We kicked off our communication channels with *social media*, our *blog*, and our *Awareness Wednesday* video series. We have used these channels as calls to action, forums to raise awareness, and celebrations of the inspiring efforts we've seen on our journey. We featured *collaborators* **PlayGrand Adventures** and **S.T.E.P.S. with Horses** via *Awareness Wednesday* and the *blog*; blogged about Prop 5 in support of **Texas Parks & Wildlife Foundation** after meeting at a *Center for Nonprofit Management Funder's Forum*; and were featured on **Nonprofit Megaphone's** *podcast* after meeting them in a digital fundraising workshop. They in turn taught us about Google Ad Grants on *Awareness Wednesday*. Our most-viewed video by far featured adoptable dogs at **DFW Rescue Me** - several have since been adopted! We will continue communicating on behalf of our collaborators and will also access *communication as a tool for education and empowerment* in 2020.

COLLABORATING

Collaboration allows us to *optimize impact* by *sharing strengths, ideas, and strategies*, and we're very excited to have ended 2019 with a plan for collaboration with **PlayGrand Adventures**. Together, we will *create a business plan* for their development of MA's Cafe, an innovative concessions area staffed by people with disabilities on the grounds of PlayGrand Adventures. Fortuitously, we met **Hugs Cafe**, a restaurant with similar goals to PlayGrand Adventures, attending the **Global Village Market**, which was featured on *Awareness Wednesday*. We look forward to expanding and developing collaborative opportunities in 2020 with other organizations including **S.T.E.P.S. with Horses** for therapeutic riding and the **Grand Prairie court system** for meaningful community service opportunities for minor offenders. We will lean into volunteerism, justice, scholarship, thoroughbred aftercare, creating opportunities, breaking down barriers, and empowering social change.

CLOSING GAPS

We strive to help others by closing the opportunity gap for people in need. For us, this comes down to *equity* - in opportunity, in education, in access, and more. In 2019, most of our grants were awarded to organizations who focus on closing gaps for people in need, from our larger gifts to **PlayGrand Adventures** and **S.T.E.P.S. with Horses**, to the \$8,000 in board member designated gifts and \$5,000 in end-of-year gifts we distributed to nonprofits in Grand Prairie including **Lifeline Shelter for Families**, **Children First Counseling Center**, and **Grand Prairie United Charities**. Closing gaps is also about helping our nonprofit collaborators. If we can assist them with funds to *close budget gaps* and volunteers to *close staffing gaps*, they can focus on the important work of their programs. In 2020, we look forward to closing gaps and advocating for equity.

Revenue

Hope 4 All was founded with \$1,000,000 from a single donor. Additional income was earned from bank account interest. Revenue diversification strategies, such as earning investment income and cultivating new donors, will begin when our 501c3 status is confirmed by the IRS in 2020.

Expenses

Fundraising activities will begin in 2020 when our 501c3 status is confirmed by the IRS.

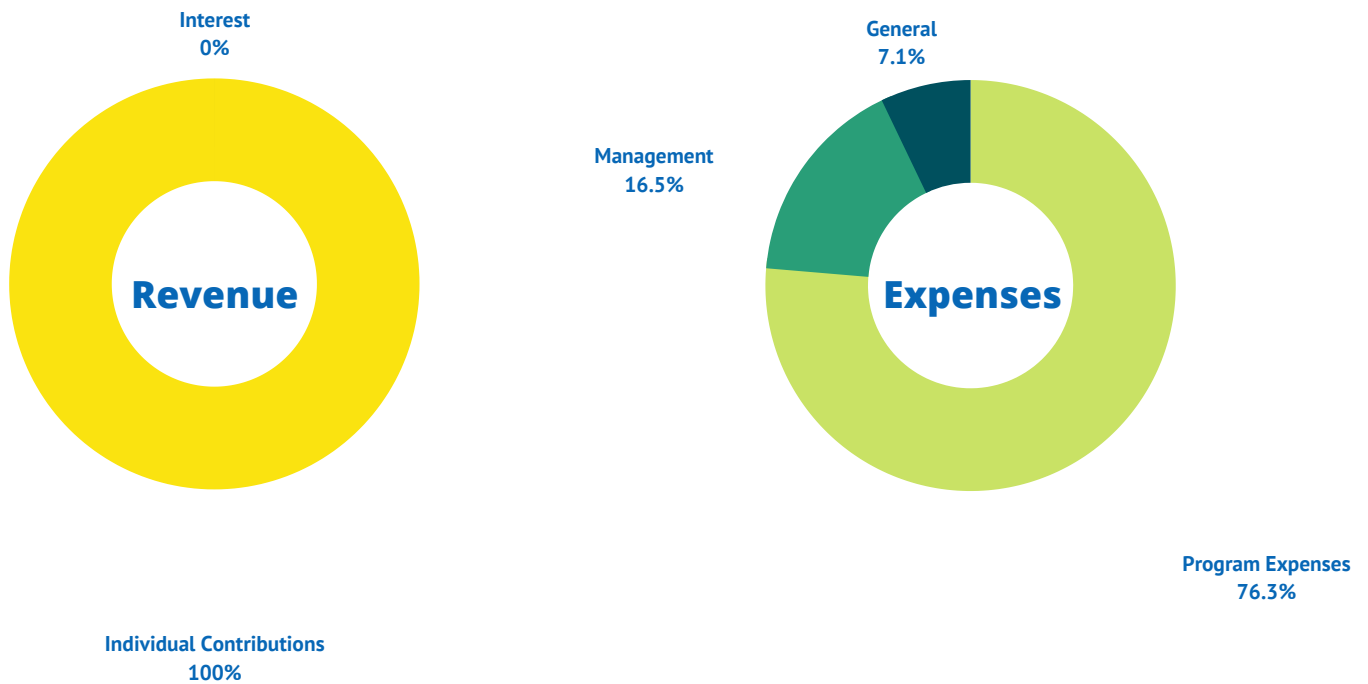
Managed Grants refer to longer term projects that require progress checks with Hope 4 All. These were not available in 2019 due to our shortened operating year.

Direct Gifts refer to financial donations for short-term needs.

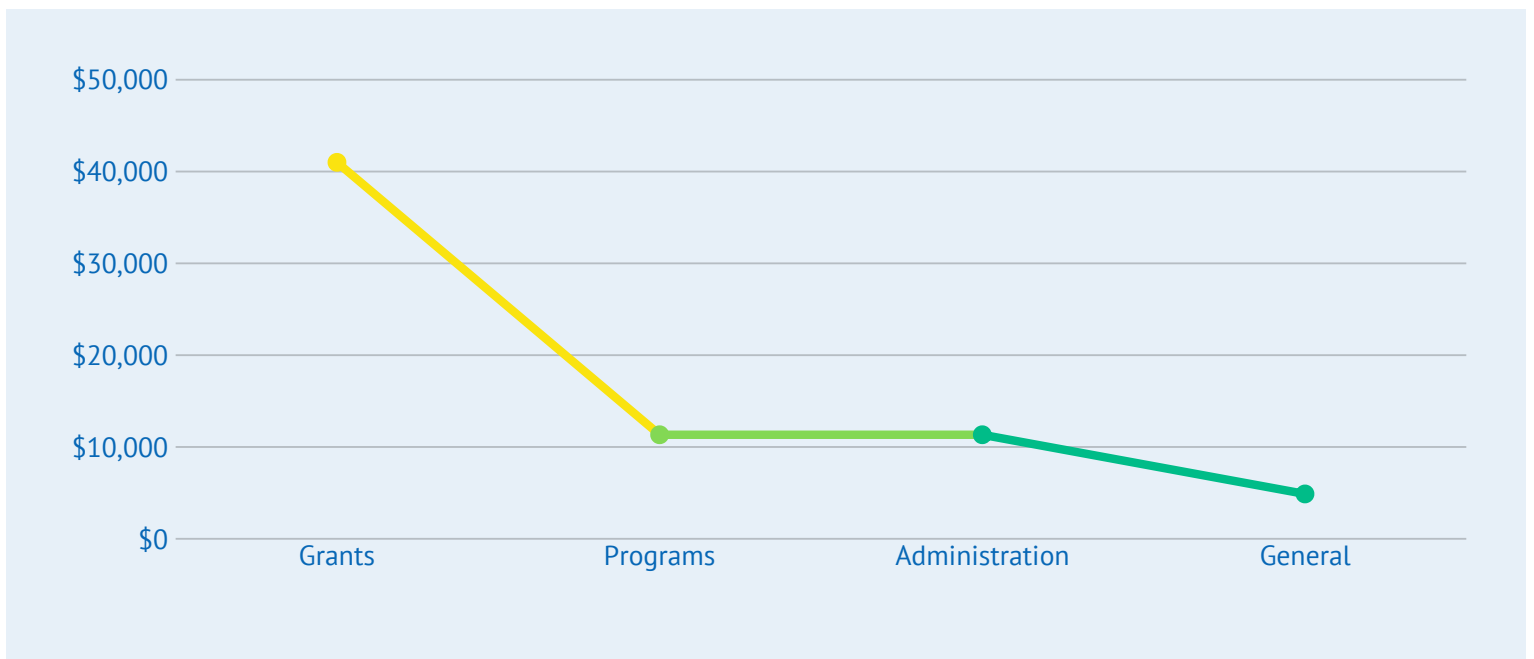
Collaborations are a combination of financial and non-financial support that help Hope 4 All and collaborators meet a common goal.

Each year, in gratitude for their commitment to Hope 4 All, board members designate an organization to receive a financial gift of \$1,000.

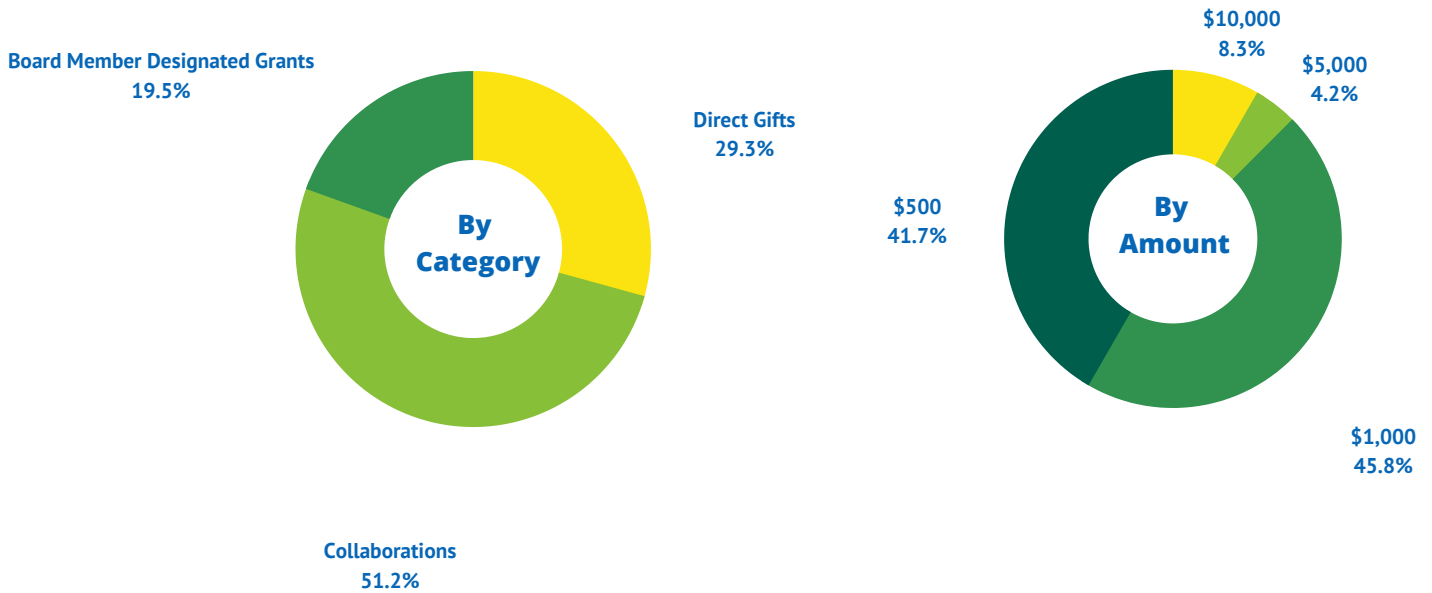
REVENUE & EXPENSES



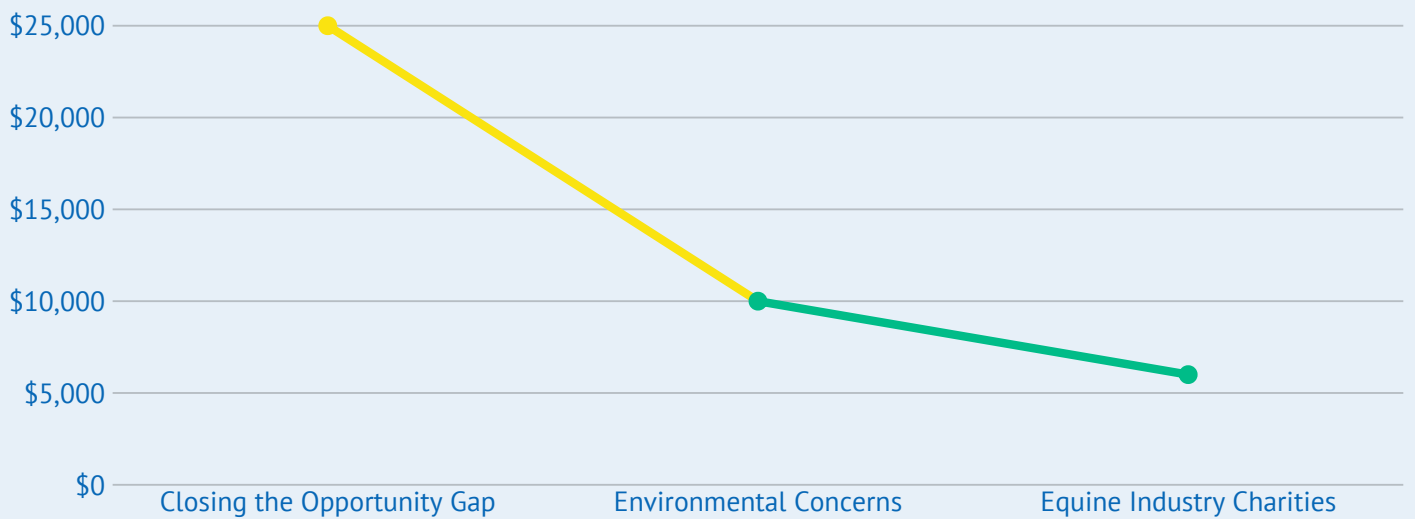
BREAKDOWN OF EXPENSES
